Parcel data from Davis and Salt Lake Counties were used to determine potential property impacts by option. The Counties' parcel data do not have complete property address information for the project area. Where the addresses are missing, the column is labeled with the parcel identification number and an approximate address. If more information is known about the area, it is included in the Notes column. The parcel data, as maintained by the Counties, do not always align well with the actual locations on the ground. For this reason, the property impact tables in this appendix should be considered an approximation only.
